3. Buildings with a required plumbing fixture count less than 12.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architect's or engineer's seal and signature.

V. APPLICANT SIGNATURE

GENERAL: Plumbing work shall not be started until the application for permit has been issued. All installations shall be in conformance with the Current Plumbing Code. **No work shall be concealed until it has been inspected.**
When ready for an Inspection, call the Building Department providing as much advance notice as possible. The inspector will need the **job location** and **permit number**.

“Section 23a of the State Construction Codes Act of 1972, Act no. 230 of public Act 1972, being Section 125.1523a of the Michigan Compiled Laws, prohibits a person from conspiring to circumvent the licensing requirements of this State relating to persons who perform work on residential buildings or a residential structure. Violators of Section 23a are subjected to civil fines.”

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.

- ✓ **24 HOUR NOTICE REQUIRED FOR INSPECTIONS.**
- ✓ **A permit must be taken out before work is started and this office must be notified when work is completed.**
- ✓ **Any changes in plans or specifications Must be approved by plumbing inspector.**
