## **ZONING BOARD OF APPEALS REQUIREMENTS**

In order that a variance may be granted on the ground of practical difficulties the **Applicant must prove all of the following**:

|--------------------|--------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------|
|                    | Upon meeting the requirements of 7.02 (G), the Board of Appeals shall review each case individually to ensure that each of the following standards are met as to the proposed variance. The Applicant bears the burden of proof. Failure to meet any one of the following standards shall result in the denial of the request: |
| Section 7.02 (G) 1 | A specific provision of the Ordinance prevents the property owner from engaging in a particular aspect of a permitted use or approved Special or Conditional Land use.                                                                                                                                                         |
| Section 7.02 (G) 2 | That there are unique, exceptional, or extraordinary conditions or circumstances that are inherent to the property in question and that do not apply generally to the other nearby properties in the same zoning district.                                                                                                     |
| Section 7.02 (G) 3 | The exceptional or extraordinary conditions or circumstances are not the result of the actions of the applicant taken after the adoption of this Ordinance. Any action taken according to lawfully adopted regulations preceding this Ordinance will not be considered self-created.                                           |
| Section 7.02 (G) 4 | That such variance is the minimum variance that will make possible the reasonable use of the land, building or structure and is necessary for the preservation of a substantial property right. The possibility of increased financial return shall not of itself be deemed sufficient to warrant a variance.                  |
| Section 7.02 (G) 5 | That the granting of the variance will not impair or be injurious to the neighborhood or adjacent properties or otherwise detrimental to the public health, safety, or welfare with regard to light or traffic or other public interests.                                                                                      |
| Section 7.02 (G) 6 | That the condition of or situation as to the specific piece of property or the intended use of the property for which the variance is sought is not of so general or recurrent nature as to make it more reasonable and practical to amend the Ordinance.                                                                      |

These tests shall apply whenever a variance is sought. Variances are not to be granted where such action will result in the circumvention of the general intent of the Ordinance or to meet a situation that may be resolved by a request for rezoning (eg expanding a permitted use into a district not permitting such use, erecting a building for use permitted in another district, increasing the density of a lot, parcel or group thereof, etc.). The decision of such Board shall be final in so far as it involves discretion or the finding of facts.
