

**FRENCHTOWN CHARTER TOWNSHIP PARKS PAVILION PERMIT**

**THIS PERMIT IS FOR THE PAVILION ONLY & DOES NOT EXCLUDE OTHERS  
FROM USING THE PARK & EQUIPMENT  
RENTAL PERMIT REQUIRED FOR SATURDAYS & SUNDAYS ONLY**

**PARK & PAVILION REGULATIONS**

1. Parks are open from 6:00 A.M. to 11:00 P.M.
2. Intoxicating beverages are prohibited
3. Premises must be left in the same condition as when reserved
4. The authorized representative who signs the permit, also referred to as the permit holder, must be 21 years of age and shall accept full responsibility for the order conduct of the persons who attend the function and for any damage to park property.
5. Gambling, Admittance Fees, and Commercial Demonstrations are prohibited.
6. Motorized vehicles are prohibited from play areas. Park only in designated parking areas.
7. Frenchtown Charter Township reserves the right to request police supervision at any function with the cost to be incurred by the permit holder in advance.
8. These rules pertain to Township Parks and there shall be no deviation from them.
9. Driver's license or picture I.D. is required of the Permit Holder.
10. A non-refundable pavilion permit fee in the amount of \$25 shall be required.
11. Township Parks Regulations Ordinance No. 196, as amended, applies to use of all Township Parks.
12. **BE SURE TO HAVE YOUR RENTAL AGREEMENT IN YOUR POSSESSION WHILE OCCUPYING THE PAVILION.**
13. If a conflict should arise due to another occupant claiming reservation during your paid rental time, please contact the Monroe County Sheriff's Office – (734) 243-7070.
