ARTICLE 21.00 SCHEDULE OF REGULATIONS

The following regulations regarding lot sizes, yards, setbacks and densities apply within the Zoning Districts as indicated, including the regulations contained in the footnotes to the Schedule of Regulation Table (See Pages 388-391) No building shall be erected, nor shall an existing building be altered, enlarged or rebuilt, nor shall any open spaces surrounding any building be encroached upon or reduced in any manner, except in conformity with the regulations hereby established for the district in which such building is located. No portion of a lot used in complying with the provisions of this Ordinance for yards, courts, lot area, occupancy, in connection with an existing or projected building or structure, shall again be used to qualify or justify any other building or structure existing or intended to exist at the same time.
